The 1<sup>st</sup> selection round is to select the best candidates according with a homogenous distribution among tracks and countries to study JMPMB with Erasmus Mundus scholarships.

It is expected that those who have been offered an Erasmus Mundus scholarship sign the Student agreement on May thus accepting the study offer.

### III. Waiting list and the 2<sup>nd</sup> round

If any of nominated candidates for Erasmus Mundus scholarship refuses the offer to study JMPMB, his/her place can be offered to the candidates from the waiting list based on the ranking but keeping the distribution of scholarships by country or region and track.

All candidates from the waiting list are invited to participate in the 2<sup>nd</sup> round of the selection, where the Programme Board have decided to offer places with 100% and 50% discount for tuition fee with some EU-CONEXUS partial scholarships to cover part of living costs for 6-12 months.

### IV. Appeals

The Selection Committee and Programme Board guarantee an absence of any conflict of interest as well as transparency and equal treatment for all applicants.

In case of any objection in any stage of the application, selection and admission process, the applicant may file his/her appeal to the Academic Coordinator at the Programme Coordinator University at <a href="mailto:academic.coordinator@eu-conexus.eu">academic.coordinator@eu-conexus.eu</a>

The appeal shall be dealt by the Programme Committee within 5 working days, or if the complaint requires more time to verify the facts and/or documents, to notify the person about possible time to answer.
