# Political Environment and Regulatory Framework for the Alliances

## Studies and Publications

#### January 2023

The European Universities Initiative: first lessons, main challenges and perspectives, Directorate-General for Internal Policies, Policy Department for Structural and Cohesion Policies (study requested by the European Parliament, CULT Committee): The study sets out the threat of non-sustainability of the European University Initiative in light of the lack of long-term perspective of funding and a missing legal framework.

#### March 2023

Final Report of the Study on the state and effectiveness of national funding systems of higher education to support the European Universities Initiative. Directorate-General for Education, Youth, Sport and Culture Youth, Education and Erasmus+: The analysis of the fragmented national funding systems for European University Alliances concludes by recommending harmonized national support via a performance based funding system for universities participating in Alliances.

#### March 2023

The road towards a possible joint European Degree: identifying opportunities and investigating the impact and feasibility of different approaches. Directorate-General for Education, Youth, Sport and Culture Youth, Education and Erasmus+: The study shows the work done and the way forward on creating a European degree first as a "label" and eventually as a "joint degree".

#### April 2023

Assessment of the Horizon 2020 support to the EUI

(presentation to FOR-EU), TetraTech: A summary report on the evaluation of the SwafS support to European University Alliances concluding that Horizon 2020 support benefits in particular smaller and HEIs and HEIs coming from Widening countries and that continuous support and synergy of grants are necessary for keeping up transformational potential.

## Erasmus + Policy Experimen- 2nd Rectors' meeting, tation Projects launched

On 31st of January 2023 Commissioner Mariya Gabriel announced the selection of 10 projects:

- 6 European degree label (21 alliances participating)
- 4 legal status (3 alliances participating)

EU-CONEXUS is participating in both pilots: UCV is representing EU-CONEXUS in ED-AFFICHE (coordinated by UNA Europa/ KTU Leuven) piloting a European degree label and EU-CONEXA participates as associated partner in ESEU (coordinated by ECIU/ University of Twente). By participating in the policy experimentation projects EU-CONEXUS reaffirms its interest and strong involvement in transforming the policy context for strategic and long-term oriented transnational cooperation of universities.
