2nd ROUND SELECTION PROCESS

Eligibility and assessment of applications

Virtual meeting, 25/04/2024

Selection Committee has received 38 submitted applications for the 2nd selection round (application submission deadline 31/03/2024) to study Joint Master Programme in Marine Biotechnology starting in the academic year 2024-2025.

The 2nd round was to select the best candidates to study JMPMB with the following characteristics;

- ✓ Up to 10 grants with 100% of exemption of fees.
- ✓ Up to 5 grants with 50% of exemption of fees.

These discounts will be offered to the best candidates from the first-round waiting list and 2nd round candidates who succeed the interview process.

*The number of available places per track (specialization) will be considered to ensure the homogenous distribution of students among the tracks. The JMPMB is not obligated to fulfill the 15 grants available during this round.

**The tuition fee waiver does not include accommodation, travelling, and any other living costs of the Student.

- I. Selection Committee has evaluated each application for its eligibility to study JMPMB:
- first the formal aspects were checked (required documents, documents in English, etc.),
- and then the eligibility requirements were reviewed.

The relevance of the Bachelor's degree (or equivalent) of the applicant in respect to the access to the second cycle studies and the JMPMB programme were assessed:

- The degree issuing higher education institution must be an accredited institution in the country where the studies are conducted/registration of HEI and to have a right to issue the degree which is submitted.
- The programme must be accredited for the period when the applicant has studied there.
- The qualification must provide the access to Master's studies.
- The qualification must be recognized by the NARICs (National Academic Recognition Information Centers) of the Partners.
 - *This verification will be carried out throughout the selection process.
- The qualification (or together with additional formal and non-formal qualifications) shall meet specific requirements to study JMPMB.
