Poster abstract instructions

1. One paragraph of text, 200-300 words long. A summary of the entire poster.
2. Sections (in order):
 - **Title:** The abstract title conveys the content/subject of the poster. The title may be written as a question or the title may be written to suggest the conclusions, if appropriate. A short concise title may more easily catch a reader's attention. Try to not use abbreviations or acronyms in titles.
 - **Purpose (Importance and Objectives):** The introductory sentence(s) may be stated as a hypothesis, a purpose, an objective, or as current evidence for a finding.

Hypothesis is a supposition or conjecture used as a basis for further investigations. Purpose is a statement of the reason for conducting a project or reporting on a program, process or activity.

Objective is the result that the author is trying to achieve by conducting a project, program, process or activity.
 - **Materials and Methods:** Briefly describe the methods of the project to define the data or population, outcome variables, and analytic techniques, as well as data collection procedures and frequencies. A description of statistical methods used may be included if appropriate.
 - **Results:** the results should be stated succinctly to support only the purpose, objectives, hypothesis, or conclusions.
 - **Conclusions:** The conclusion(s) should highlight the impact of the project and follow the method and results in a logical fashion. This section should not restate results. Rather, the utility of the results and their potential role in the management of the project should be emphasized. New information or conclusions not supported by data in the results section should be avoided.

Each section typically consists of 2-4 sentences. No tables and no figures.



Poster formatting instructions

1. Poster Size and Layout:

- Dimensions: A0 (841 mm x 1189 mm or 84.1 cm x 118.9 cm)
- Orientation: Portrait (Vertical)
- Margins: Minimum 2.5 cm margins around the edges

2. Sections to Include:

Title, Authors, Introduction/Background, Objectives / Problem Statement, Methods / Approach, Results/Findings, Discussion/Conclusion, References, Acknowledgements (if necessary).

3. Font Types and Sizes:

- Using Arial and Calibri for consistency and readability.
- Title: Font: Arial, Size: 90-100 pt, Style: Bold, centred.
- Authors: Font: Calibri, Size: 50-60 pt, Style: Regular, centred under the title.
- Section Headings (e.g., Introduction, Methods, Results): Font: Arial, Size: 50-60 pt, Style: Bold, left-aligned.
- Body Text: Font: Calibri, Size: 28-36 pt, Style: Regular, left-aligned.
- Captions for Figures and Tables: Font: Calibri, Size: 24-28 pt, Style: Italic or regular, under the figures.

4. Line Spacing: Body Text: 1.2-1.5 line spacing for clarity. Between Sections: Leave about 2 cm of white space.

5. Colours: Background: Light colours (e.g., white, light grey). Text Colour: Black or dark-coloured text for better contrast. Avoid: Bright or clashing colours.

6. Visuals (Figures, Charts, Graphs): Resolution: Use high-resolution images (300 dpi or higher), Size: Visuals should be at least 15-20 cm wide, Labels: Clear titles, axis labels, and legends where applicable.

7. Alignment Consistent alignment of text boxes and visuals. 8. Overall Readability: Ensure readability from a 1.5 - 2-meter distance. Use bullet points and lists for clarity. Keep text concise.
