

EU-CONEXUS JobTeaser Competition – Terms & Conditions

1. Promoter

This competition is organised by the EU-CONEXUS Career Network, led by South East Technological University (SETU), on behalf of the EU-CONEXUS European University Alliance.

2. Eligibility

The competition is open to:

- Current students enrolled at an EU-CONEXUS partner university
- EU-CONEXUS alumni members

Participants must:

- Be aged 18 years or over at the time of entry
- Meet the eligibility requirements outlined above

The following are not eligible to enter:

- Individuals directly involved in the organisation or administration of the competition
- Employees responsible for selecting the winner

3. Competition Period

The competition opens on May 11th 2026 and closes at 11:59pm CET on May 30th 2026

Entries received after the closing date and time will not be included in the prize draw.

4. How to Enter

To enter the competition, eligible participants must complete one of the following during the competition period:

- Create an account on JobTeaser through their EU-CONEXUS university access route

Only one entry per person will be counted. Multiple entries submitted by the same individual or through duplicate accounts may be disqualified.

5. Prize
